Dear Senator/Congressman:

Subject: Opposition to Proposed \$100 Per-Flight User Fee

As part of the current "fiscal cliff" negotiations and ongoing budget discussions, a proposal has been advanced in Washington that would establish a new "\$100 Per-Flight User Fee" on certain segments of the general aviation industry. No one enjoys paying taxes, and no one wants to pay more in taxes than absolutely necessary. The general aviation industry is no exception, but some tax systems are better than others.

General aviation fuel taxes are the best way for the industry to contribute necessary revenues to federal coffers. Fuel taxes are easy to pay, efficient to collect, simple to understand, and directly related to use of the system.

A new user fee would require creating a costly new federal billing and collection bureaucracy to administer. It also would impose a significant administrative burden on individuals and small businesses that suddenly would have to process invoices, dispute erroneous bills, and establish new recordkeeping systems. Per-flight user fees have been tried in other countries and proven to be enormously destructive to general aviation. Please do not initiate the fee here.

General aviation is a significant American industry that generates 1.2 million jobs and \$150 billion in economic activity. It is one of the few U.S. industries that contribute positively to our nation's balance of trade. Moreover, general aviation in Michigan supports economic development opportunities and jobs. General aviation helps companies of all sizes to be efficient and productive, and provides important humanitarian relief during crises. Unfortunately, the recent economic downturn decimated this essential American industry, and it still has not fully recovered.

While not perfect, the fuel tax is the easiest and most efficient way to fund the Federal Aviation Administration and its programs that benefit all users of the system.
